**Annual Newsletter** 

Wow, time is really flying by, seems like it was just yesterday that we were at our reunion at the Wisconsin Dells. This year our reunion will be at Sam's Town in Las Vegas, Nevada. We have negotiated some pretty reasonable rates for the Hotel. This year, the association will be paying 50% of our Activity Fees for our Association Members who decide to go on the Hoover Dam Tour and the Black Canyon Tour. There is lots of photography opportunities for the photographers in our group - Mountain Goats, Hot Waterfalls, and waterfowl. It is unbelievable what the people building the dam had to undergo during the building of the Dam in the 30's. The guides provide educational information regarding the people building the dam and you can witness the paths people had to take when working at the dam.

Sam's Town provides a 9 Story Atrium for those that want to get away from the noise of the Casino. The Hotel/Casino is off the strip, but for those wanting to experience the Las Vegas strip, Sam's Town provides a shuttle approximately every 1 1/2 hours to Harrah's on the strip or for the trip from the strip to Sam's Town. Unfortunately they stop providing this service around 9 p.m. They do provide Shuttle service from 9 a.m. to 9 p.m.

The Hotel/Casino also provides a Bowling Alley and a Theater featuring 7 different movies as well as a horse racing/ betting book for Football and other activities. The Hotel also provides a work out area and a swimming pool for our association members.

Sam's Town also has additional rentals for the disabled. The Hotel/Casino has Scooters for rent at \$100 for three days. For those over 300 pounds, the Hotel/Casino provides a heavy duty scooter for rent at \$105 for three days. For the handicap accessible rooms, they have rooms that have roll in showers or tubs with rails and drop down seats for the tubs, these rooms are based upon availability and do sell out. The Hotel/Casino suggests that if you require an accessible room that these people should book the room as soon as possible.

Shuttle Service from the Airport to Sam's is available at the Las Vegas Airport. I prefer the Super Shuttle. According to Sam's club, the cost will run from \$25 to \$35 to and from the casino.

Today I brought Eddie home from the hospital. This has been a very difficult week to say the least. Eddie's temperature has fluctuated all week and is still doing this now. After I got him home his temp was 100.4...Hopefully he can control it better here at home. I have been keeping a log to show the Doctors. He woke up this morning with very little voice, barely a whisper and the right side of his neck swollen. The Doctors have no clue except to say the only thing they can determine causing all of this is the aggressive treatment. They have done blood cultures, scans, and everything they possibly know to do. They even called in an Infectious Disease Doctor yesterday and he agreed with the Oncologist that he thought it all was related to the treatment. A Doctor brought 5 students in so they could observe what severe mucositis looks like and what Eddie is having to deal with. What is so bad, they want him to go back to Radiation on Monday but are giving him a break from Chemo until the 20th. There is no way I can explain to you how rough this has been. Eddie remains a fighter and is still eating without using his feeding tube. It takes him a lot longer and he coughs throughout the meal but he gets it down. Let's all pray God gives him the strength to remain strong and continue fighting as he continues his treatments.

On a sadder note, we have lost three of our Marine Corp brothers and sisters this year. We have lost Charley Baldwin, Sgt Major Don Aakers wife Claudia Aaker and Ron Sower this year. Rest in Peace.

#### Message from your Treasurer

It has been a busy year for me, however, I have persevered. One of the things that I have changed with the approval of our officers is the Fiscal Year End for our Association. I have changed our Fiscal Year End (FYE) to September 30th. This will allow us to view all of our Income/Expenses that is related to that year, rather than co-mingling prior year data with the current year financial information. I think that we all can agree that most of our activities will occur between October 1st thru September 30th (our accounting cycle). Previously our Fiscal Year End was July 31st (August 1st thru July 31st).

I have also changed our method of accounting to the accrual basis rather then the cash basis with the approval of our officers. This will enable us to accrue Income/Expenses related to the current year. Two things come to mind, people that have paid in advance are liabilities to our association rather than current year income. Another thing that comes to mind is Income from our Auction. This can be estimated and recorded as income before we actually have that income. I can adjust this to actual after the reunion.

Another thing that I have completed is entering the prior year Income/Expenses from our reunion at the Dells for comparison purposes. From what I understand, we shouldn't be making money from our association members. Our goal is to break even.

Since our last reunion, we have picked up 34 new and returning members to our association. This is as of May 16, 2015.
